Pennsylvania Game Commission target of audit by Pennsylvania Auditor General

ennsylvania Auditor General Eugene DePasquale todav I launched a "performance audit" of the Pennsylvania Game Commission. He described the upcoming audit as "an independent assessment of the commission's revenue and expenditures," but noted that he will "evaluate the commission to ensure its resources are being used to benefit the millions of Pennsylvanians who enjoy hunting, trapping and other outdoor recreational activities." Noting that this will be "the first performance audit of the Game Commission in nearly a decade. DePasquale said the audit will cover July 1, 2014. through June 30, 2017, identifying and analyzing "all sources" of revenue and expenditures, and the acquisition of property by the commission. DePasquale was joined by Rep. David Maloney, R-Berks, who the auditor general said "has been on me tirelessly to do this audit for at least a year and a half." However, he noted, other representatives of both political parties have expressed support for the audit. the fiscal aspects of the audit addressed by DePasquale, Maloney discussed deer management by the Game Commission, declining numbers of hunting license sales and complaints of revenue lost by businesses due to declining partici-"If we do not have the product, we will pation in hunting. not have the pursuit of it," said Maloney, who noted that the "No. 1 reason for hunting license sales... is to pursue whitetailed deer." Asked in the press conference if his audit will examine deer management by the commission, DePasquale

said, "We will be looking at the regulations of the Game Commission making sure they comply with the regulations. For example, when we look at something based on science, or that is supposed to be based on science, we don't go in and question the science. We make sure they are following the proper procedure." DePasquale was asked if the audit he had just announced could impact game management.
